Terms of Rental Agreement

Weed Department rental equipment must be checked out, paid for, and used by legal adult residents of Uintah County. Rental agreements are nontransferable. Rental equipment may not be used outside of Uintah County. A deposit is required to rent equipment spray equipment and may be partially or fully refundable. The deposit may be applied to rental fees, late fees and/or damage fees where applicable. Rental equipment must be used in a manner consistent with its intended use. Rental equipment must be returned by the listed due date on the Agreement. Rental equipment that is returned after the due date is subject to a late fee which may be garnered from the renters deposit. Rental equipment that is returned damaged is subject to a damage fee up to the full amount of the deposit. Any fees left unpaid 30 days after rental due date may be applied to the renters property taxes. Equipment not returned after 30 days will be considered stolen and will be reported to legal authorities and the full cost of stolen equipment may be included on the renters property taxes. The rental of Weed Department equipment requires that the renter behave with legal and ethical conduct in the application of EPA approved herbicides in a manner consistent with its labeling. Although the Weed Department offers equipment for rent and may suggest certain herbicides for use, the renter is responsible to read and follow all rental instructions and herbicide labels and they accept full responsibility for the consequences of their actions while applying herbicide as to the effects of the herbicide application on plants, animals, humans and/or the environment in or near the application area. The County accepts no responsibility for damages to life, property, and/or the environment caused by the misuse of rental equipment, personal equipment, and/or the application of herbicides. The County shall reimburse a renter for damages to the renters personal equipment if damages are determined to be caused by normal use of Weed Department rental equipment. Misuse of Weed Department rental equipment and normal wear and tear of personal equipment is not covered by this agreement. The renter understands that this rental equipment may not be used for commercial herbicide applications. Liquid herbicides are recommended for use in rental equipment. Wettable powders, in excess of 3 ounces per 24 gallon tank or 6 ounces per 50 gallon tank may not be used as damage may occur to the spray unit. Renter agrees to rinse the spray tank, hoses and accessories with clean water inside and out prior to returning equipment.

Rental Spray Unit Instructions

Check out and return is available from 8:00 a.m. to 5:00 p.m. Monday through Thursday. The Weed Department is closed on all state and federal holidays.

Because rental equipment is used with many different herbicides and chemicals, the Weed Department recommends that rental tanks be used to spray noncrop areas such as pastures, rangeland, rights-of-way, fence lines, ditch banks, and gravel areas to avoid damage to nontarget organisms such as crops, gardens, and ornamentals.

A spray unit includes: Spray tank (24 or 50 gallon model) with two 15' Boominator boomless spray nozzles, one Green Gard spray handgun, one spray hose (10' on 24 gallon model and 50' on 50 gallon model), one 4 gpm electric pump, battery connector gator clamps, two nylon ratchet tie downs.

The spray units have been calibrated to spray 1 acre per 25 gallons of water using the booms at 4 mph or approximately 1/4 acre per 25 gallons of water using the handguns spraying to wet (not runoff).

1. **Inspect the equipment** to assure that equipment is clean, that no damage is present, and that all required accessories are included before signing the agreement and taking equipment with you.
2. **Test the booms and handguns.** Fill the tank part way with clean water, turn on pump and operate booms and spray guns to assure proper function and alignment. Turn off booms, hand guns, and pump. Notify the Weed Department immediately if does not pump water with good pressure.
3. **Add appropriate amount of herbicide(s)** and other approved chemicals (surfactant's, anti-foam agents, dyes). Wettable powders, in excess of 3 ounces per 24 gallon tank or 12ounces per 100 gallon tank may not be used as damage may occur to the spray unit.
4. **Finish filling tank** with required amount of clean water
5. **Spray out all herbicide.** Remaining herbicide often may be stored in properly labeled containers or sprayed on gravel drives, gravel parking areas, along roadsides, or idle waste areas. Refer to herbicide label requirements for disposal instructions.
6. When spray job is complete, **rinse tank and flush all hoses** with several gallons of clean water and spray off tank exterior with clean water.
7. **Return cleaned equipment** and accessories to Weed Department on or before the due date.
